## City of Carrabelle Applies for loan to purchase Water Management

Pinki Jackel, the Chair of the Franklin County Board of Commissioners, spoke to members in attendance at the May Civic Club meeting. She went over several of the landscaping efforts by the County on the Island and other items. She then surprised everyone by announcing that the City of Carrabelle has applied for a \$15 million loan to purchase the water management system (WMSI) on the Island.



*Pinki Jackel* As long as Water Management Services own the water utility as a private company, they must have approval of the

**Public Service** Commission just as they are doing now. However, a municipality does not have to get approval and can raise water rates at will. As happened recently when the City of Carrabelle annexed the Lanark Village water supply. Commissioner Jackel had just heard about this development before coming to the Civic Club meeting. Civic Club member, Gail Riegelmayer, had also heard about the loan request and presented several sales options to those present: 1. Water Management sells to another private utility company. 2. The City of Carrabelle gets the loan and purchases the utility. 3. The residents of St. George Island form a Cooperative to purchase the utility. The options are not many and research needs to be done. Several members talked about how well they had been treated by Talquin Electric Co-op based out of Quincy. (See Page 2, Carrabelle)

## County Commission Meeting, June 5

by Fran Giknis I am happy to report that the Franklin Count Commission voted unanimously yesterday on Commission Chairman Pinki Jackel's request to formally urge the State Government to intercede to delay the approval of a \$15 million loan from the Florida DEP to the City of Carrabelle.

As the Commission Chair, Pinki could not make the motion, which was made by Commissioner Cheryl Sanders. Commissioner Sanders said that she had learned only last week of the plan for Carrabelle to buy the utility. At that point, the County attorney said, "well, then you are not going to be happy to hear that in my preliminary investigation, I learned that the sale has been in the works for six months". None of the commissioners were pleased, and Commissioner Sander's motion was seconded by **Commissioner Smoky** Parrish, who said that he approved in part because he had received "over 100 (See Page 2, FCBOC Meeting)

(Carrabelle, from Page 1) Tom Slocum suggested the Civic Club hold a town meeting for home and business owners. (FCBOC Meeting form Page 1) emails that locked up my computer" requesting the action. Commissioner Sanders said she believed that the transfer of ownership should only take place if it was the will of the people served. She asked Attorney Michael Schuler to see if the County Commission had standing to approve (or disapprove) the sale. The Commission felt that at the very least, a municipality that was considering taking ownership of a utility that served another community should notify the governing body of that community of their intent. The actions of the City of Carrabelle were thought to be a breach of respect and courtesy. Commissioner Sanders said that she was "very disappointed with the City of Carrabelle Board and very supportive of the delay of the loan and an investigation". **Commissioner Putnal** worried what would happen if Gene Brown just "walked away" from the operation, leaving the Island without water. **Commissioner Jackel** replied that WMSI was a profitable business with a payroll and that Mr. Brown

was paying himself a salary so it was very unlikely to happen. Attorney Schuler reassured the Commission that the State's regulatory function would prevent this worstcase scenario from happening. In urging delay of the loan, **Commissioner Jackel** noted that there was a DEP meeting scheduled for August 7, but that this meeting would be after the loan was granted if it stayed on track and that the sale would be downstream at that point. The Commission will urge DEP to meet with them (and Island residents) soon. In other conversation at the meeting, the Commission discussed the DEP's seagrass bed restoration, the probability of getting permit approval to dredge the Eastpoint Channel within 3-6 months (after many years of effort on this request), progress on getting the airport up to speed and the appointment of Fonda Davis as the Landfill Director, and other miscellaneous business. **Committees formed to** 

study purchase of WMSI Commissioner Pinki Jackel held a town hall meeting at the volunteer fire house on Tuesday, May 29 to discuss the ramifications of the purchase of the Island's water system (WMSI) by the City of Carrabelle. The meeting was attended by over 60 SGI owners, a representative from the City of Carrabelle and a couple of employees of WMSI. The consensus was that the stakeholders needed more time and information before it would be known if the potential purchase would be a positive or negative effect on the cost of water services to the businesses and residences on the Island. A couple of committees were set up to study the situation and how to communicate this information to the stakeholders. The first committee was to look at the options available to the community (as was mentioned in the lead article in this newsletter). The volunteers on this committee are Newt Colston, Bud Hayes, Ed Aguilar, Tom Slocum, Karen Rudder, Don Murray, Duke Douglas and Barbara Sanders. The first meeting was on May 30, and they came up with

The first meeting was on May 30, and they came up with the following assignments: To identify vehicles (pathways) for user ownership of the water system, to identify other "buyers" of the SGI water system (city, co-ops, (See Page 3, Committees) *(Committees, from page two)* private, etc.) and methods of obtaining funding, if needed.

The second committee is to determine how to best get the information out. The members of that committee are Gail Riegelmayer, Fran Giknis, Jane Nipps and Eric Roberts.

Everyone agreed that the purchase process needs to be slowed down to enable affected parties time to determine what is best for the Island.
