SGI Civic Club Facilitates Meeting on the Sale of Water Management

On June 21, the St. George Island Civic Club helped the Plantation Owners
Association and St. George Island Forward hold a meeting to discuss the impending sale of Water Management System, Inc. (WMSI) to the City of Carrabelle.

The meeting was held in the Plantation Club House in order to use their better telephone conference equipment.



An email was sent out to members of the Plantation Owners Association, the SGI Civic Club and members of St. George Island Forward notifying them of the meeting and giving out information of how to RSVP or call into the conference call. Ninety seven persons attended the meeting and twenty three more attended by phone. Civic Club president Mason Bean chaired the meeting. Also present to explain the steps taken by the committee set up

during a town hall meeting last month by Franklin County Commissioner Pinki Jackel were Newt Colston and Gail Riegelmayer. Commissioner Jackel was out of town, but called in to go over issues the Franklin County Commission had with the sale. Committee Chair Newt Colston explained the financial situation of WMSI that were gathered from public records. He also said that a LLC has been formed to have one specific group to handle efforts to delay approval of the sale. Gail Riegelmayer spoke of options we have as property owners on the Island. Questions from the telephone participants were emailed and passed onto the speakers by Jane Nipps. Many people from the audience also had questions. The questions ranged from basic questions on how Carrabelle would be able to service the Island to if we can sue to prevent the

Tropical Storm Debby Wreaks Havoc on St. George Island

On Sunday morning June 24, Island residents awoke to high winds and driven rain as Tropical storm Debby parked herself over the Island before turning inland in Taylor County three days later. The power went out around 8 a.m. Sunday morning as three utility poles were sheared off. Also, sometime Sunday, a barge from Progress Energy broke loose and hit the fishing pier on the Island side knocking out at least two sections of the old bridge.

Progress Energy, which had already erected and wired the new concrete poles across the Bay elected to move up the connection date rather than repair the old poles. Power was restored by Thursday evening. The Bridge was closed due to high winds by Sunday afternoon, stranding many (See Debby, page 2)

(Printed on June 21) The City of Carrabelle is considering the purchase of Water Management Systems Inc. (WMSI) – the water provider for St. George Island. In order to make this purchase, the City has asked for a \$15 million loan from the State Department of Environmental Protection. A Public Hearing has been scheduled for June 29 at 3 p.m. at the City Complex in Carrabelle to discuss and decide on this purchase. It is important that you consider the following points and attend this meeting.

- The true value of
 Water Management
 Services Inc. has not
 been determined.
 This will not be an
 easy task. WMSI has
 outstanding loans for
 several million of
 dollars to the State
 and to Centennial
 bank.
- The state Public
 Utilities Commission
 is currently
 considering a WMSI
 rate increase request,
 and important issues
 are still open from a
 preceding rate case
 that need to be
 answered.

- According to the latest filing, WMSI needs about \$3 million in upgrades and repairs.
- If a private company were buying WMSI, the State of Florida would require that the true value of the company be established and the sale price would be based on that value. Since the City of Carrabelle is a municipality and not a private company, it is not required to establish this value and can pay a much higher price than the company may actually be worth. Then all water company customers would have to pay for it through their monthly water bills.
- The responsibility for repair and upkeep of the water system falls on all its customers. While this spreads out the cost, do existing Carrabelle water customers want to share the responsibility of upgrading and operating a water system with all the risks associated with providing services on a barrier island?
- Franklin County
 Commissioners have sent a resolution to the State, expressing their concerns about

the sale and asking the State to slow down the process until more can be learned and understood.

The residents of St. George Island believe that this sale is being rushed forward on an accelerated schedule before all the facts and figures can be collected and analyzed. Our interest is in receiving quality service at a fair price, regardless of the provider, but since St. George will be served by the system, it concerns the residents that we will not have a voice in selecting the members of the water board that governs this utility if the sale proceeds to the City of Carrabelle. We also believe that the people of Carrabelle, as residents of a city that is considering taking on a large debt to fund an investment in a system of uncertain value, should be very concerned. Tell your commissioners at the Public Hearing next Friday that you want to take the time to understand the details and real value of Water Management Systems Inc. before they approve the purchase of this utility.
