November Speaker Addressed Bear Safety and Recent Hunt

Caitlin Goode of the Florida Wildlife Commission spoke about the recent bear hunt in Florida and suggestions about dealing with bears.

Caitlin is the niece of Civic Club Treasurer Mike O'Connell and has spoken before at the Civic Club. In June 2015, the FWC approved a limited bear hunt to take place beginning Oct. 24, 2015 in four of the seven Bear Management Units (BMUs). The purpose of reinstating a bear hunting season was to stabilize expanding bear populations in different parts of the state that are capable of supporting hunting.

As other states have shown, hunting is the most effective and responsible method for managing the growth of bear populations but is just one part of FWC's overall approach to managing bears.

Florida black bear populations have increased greatly over recent decades. Based on rigorous scientific updates, Florida black bears number more than 3,500. FWC took a conservative approach to setting harvest objectives, building in buffers so the number of bears harvested would stabilize growing populations. Buffers were built in to ensure a continuation of healthy bear numbers. Updated population information for three additional BMUs is expected in 2016. In addition to updated population information for three additional BMUs (East Panhandle, West Panhandle and South), FWC also will use information from the 2015 hunt to guide management efforts in subsequent years. FWC had mechanisms in place for daily monitoring of the harvest and season closure, so when the harvest approached the statewide objective of 320, FWC was prepared and stopped the hunt. The East Panhandle (our area) and the Central bear management units (BMUs) were closed for the rest of the season beginning Sunday, Oct. 25 while the North and South BMUs were closed to hunting beginning Monday, Oct. 26. The total harvest for the four bear managements units open during the 2015 bear hunt was 298. (See Bears, Page Two)

The breakdown by Bear Management Unit is as follows:

- East Panhandle BMU = 112 bears
- Central BMU = 139 bears
- North BMU = 25 bears
- South BMU = 22 bears

While harvest was higher than expected in the East Panhandle and Central BMUs, success rates were comparable to other states with similar hunt structures and were within sustainable limits. The higher-thanexpected harvest in the East Panhandle likely reflects a higher bear population in that unit and indicates that the population is significantly higher than the East Panhandle's 2002 population estimate of 600 bears.

It is illegal to feed bears and other wildlife. If you encounter a bear, back away slowly and stand tall.

St. George Island Cat Allies

In November, crews of local and out of state Volunteers, Dr. Hobson Fulmer and Vet Techs from Franklin and surrounding counties worked diligently for 4 days to Trap/Neuter/Vaccinate/Release (TNVR) 91 free roaming cats on St. George Island. This event not only keeps the cat population under control and disease free, but also helps control the rodent population. This year, with the leadership of Cathy Buell, SGI Cat Allies have TNVR 377 homeless cats in the Apalachicola, Eastpoint and SGI areas. SGI Cat Allies need support to continue efforts by volunteering and making donations. SGI Cat Allies is a registered public 501 (c)(3)nonprofit organization.
