


First Key Infrastructure Project on Island in 20 Years Draws Nearer

The long-awaited St George Island Public Restroom Pavilion is finally coming to reality. The new facility is a SGI Civic Club priority for improvements to the island, ranked in "SGI 2025 Vision," a long range planning effort by the Club developed two years ago. The county planning office has released the bid package and hopes that a contract can be awarded soon, with construction beginning later this year.

According to Dewberry Engineering who designed the facility, the new Pavilion will be built south of the Cape St. George Island Lighthouse Museum & Gift Shop, prominently located near the entrance to the beach access, recreational park, and west-side public parking area. The fully ADA compliant pavilion is equipped with 10 water closet fixtures (5 men and 5 women in two detached areas) and three manual outdoor shower units.

Club members and islanders were particularly concerned about creating a maintenance-free facility, given its heavy seasonal use. The architect addressed these concerns. All water closet and lavatory fixtures are sensor operated allowing for a hands-free experience. (No paper towels overflowing the trash bin.) The interior of the restroom facility is lined with fiberglass reinforced plastic (FRP) panels from wall to ceiling. The panels have a smooth finish that is easy to clean, low-maintenance, abuse-resistant and hygienic.

The interior fixtures are LED (light-emitting diode) energy efficient lights, built with a digital timer, allowing the county to set seasonal timing of the lighting use remotely. Exterior lighting is LED with an amber color temperature, in keeping with our turtle friendly standards as well as being energy efficient.

The structure meets all current hurricane standards and is elevated on concrete piling to avoid flooding. The exterior cladding consists of cementitious siding, wood stud construction, aluminum louvers and a metal roof. All these exterior building components and materials were selected for their ability to withstand the waterfront environment and seasonal weather. The exterior lower deck of the pavilion with the outdoor shower units allows the beach goer to rinse before entering the facility or simply returning to the parking area. The breezeway landing between the Men's and Women's areas is on the upper deck, taking full advantage of the open view to the gulf.

The accessible ramps and stairways all are connected to the existing sidewalk south of the Lighthouse Museum. The existing restroom facility will remain in place until the new building is operational. The old structure may be removed at that time or turned into a dressing facility to reduce the impact on the restroom areas.

The new SGI Restroom Pavilion will be the single largest facility investment by the county on the island in more than twenty years. The Civic Club thanks Commissioner Ricky Jones, who chairs the Tourist Development Council (TDC), for shepherding this project through both the TDC and the County Commission. All Construction costs are financed through tourist short term rental fees, collected by the TDC.

The St George Island 2nd Annual Golf

2020 Candidate Forums Planned


I have a son, William, and a grandson, Buck. They love their "Pink Pink." XoXo's

Beautification work at entrance postponed until Fall

Contracting for the state beautification grant to fund improvements to the entrance to the island is postponed until the Fall to allow for better planting conditions and avoid the possibility of stormy weather. The Bid Package will be released later in the summer to provide adequate time for permitting and planning. The SGI Civic Club partnered with the County Commission to develop a proposal and receive funding for these improvements from Florida Department of Transportation and received the funds earlier this year. Funds for development of the grant application and the landscape design were paid for through a \$5000 donation from a Civic Club member.

Election time is upon us once again. Historically the Civic Club has hosted political forums wherein the candidates running for office are asked to provide the audience with information concerning themselves and their various platforms after which they are asked pertinent questions posed by the moderator and the audience. These forums are an important public service provided by the Civic Club and an excellent way to determine the suitability of a candidate for office. We intend to continue that tradition. At this time we are hoping that the health situation will permit us to host our 2020 First Primary Candidate Forum in early August. Civic Club members Dan and Loula Myers have agreed to permit our organization to use the pavilion at Doc Myers before normal business hours when a date is chosen. We are optimistically planning a September 12th event for the General Election candidates. The spacious open-air location should permit adequate social distancing for our membership. 
Record Crowds Bring Parking Nightmares

Inadequate parking is a growing problem for SGI, which has become more popular than ever with our reputation for low density development and widely accessible beaches. It seems that the lack of authorized parking spaces does not stop our eager beachgoers. They'll park anywhere!

Fortunately, a long range solution for in the business district is already in the works. In 2019, the County Commission approved the Civic Club's SGI 2025 stormwater and drainage recommendation as a top priority for the island business district. The stormwater mitigation effort includes re-engineering of many acres of county land and easements in the area, permitting the creation of pervious parking areas on Gulf Beach Drive from 3rd to 3rd. The Commission dedicated a portion of the county's RESTORE (Deepwater Horizon Disaster Settlement Funding) to perform the engineering design work, with the intention of using the same RESTORE funding source for multiyear implementation.

Meanwhile the Sheriff and County Commission have instituted aggressive ticketing and additional signage. Although county easements along Gorrie are legitimate parking areas, encroachment onto private property or blocking of driveways is subject to towing and ticketing. Private property owners are encouraged to take photographs of illegally parked vehicles and contact local towing services.

On July 7, the Commission instructed county staff to work with the SGI Civic Club and the SGI Business Association to develop additional recommendations for parking issues on the island. Watch for opportunities to participate in these critical discussions.



Certain 2020 Elections Ended in June

The Civic Club extends congratulations to our local Constitutional Officers re-elected without opposition. Rhonda Skipper, Property Appraiser, and Heather C. Riley, Supervisor of Elections, will be serving our county for another term. Neither faced opposition.

The Civic Club does not typically track non-District 1 School Board races. In the case of Fonda Davis, District 3, the Civic Club extends a special recognition. In his professional life, Mr. Davis heads up the county's Parks & Recreation program, which oversees our island playground area and pickleball/basketball facility. He is also responsible for the collection of yard trash and other solid waste, including clean up on the SGI bridge. His crew often assists with distributing pine straw for landscape beds at the Welcome Sign, and along Franklin Blvd and the parking area of Lighthouse Park. He is a valuable partner of Civic Club efforts to maintain and improve the island.

Franklin County Senior Awarded Scholarship

Cale Barber, a senior at
Franklin County School, is the
inaugural recipient of the
SGI Civic Club Eric Roberts
Scholarship. The \$500
scholarship is in remembrance
of Eric Roberts, who served as
a Civic Club officer and
communications person for

many years. To qualify, a student selects a major in some form of communications. As part of his application, Cale submitted an essay titled, "The Value of Quality Communication in Democracy and Daily Life." In his well-written composition, he addresses the importance of strong communication skills in one's ability to discern truth from propaganda and to be an active participant in communication. When asked how he developed his communication skills and interest, Cale credited not only his teachers at Franklin County School, but also his mother. Island Gets Rare Asphalt Resurfacing

The county is entering into a federally funded contract for paving improvements at Apalachicola Airport because the airport is designated as a critical facility within our regional disaster response effort. To take advantage of having a major road builder conducting operations within the county borders, the county has negotiated with the vendor to perform several modest paving projects in Franklin without charging additional staging fees. The island will soon receive the benefit of this arrangement. Utilizing District 1 road building allocation based on gas taxes, Commissioner Jones received approval from the Commission to repave West Bayshore Drive, which connects to Franklin Blvd at one of the island's most heavily trafficked corners. The work on the road is a short term fix and does not represent complete reconstruction. This same roadway is a part of a major stormwater management redesign currently planned for the SGI Business District to be paid for through RESTORE funds, awaiting release from U.S. Treasury. That project completion is several years away.

As the island's oldest, not-for-profit organization dedicated solely to the welfare of the island, the Civic Club is now a 501c3 charitable entity. That means your charitable donations are tax deductible.

For donations of \$100 or more, the Civic Club provides logo items of modest value so the entire donation is deductible. Dues are not deductible because of the variety of events provided through the Club for members' benefit.

County Looks to Raising Tourist Tax to pay for Infrastructure Needs

The Franklin County Commission is considering increasing the Tourist Development Tax by one penny, from 2% to 3%. This action does not require a referendum but can be accomplished through an extraordinary vote of the five-member county commission.

The Commission will host a public workshop for discussion of the matter on July 7th. The actual vote has not been scheduled.

The Tourist Development Tax is imposed on all short term rentals within the county boundaries, whether rented directly by property owner or through an agency. Most Panhandle counties designate only tourist-related areas to collect and use the revenues; Franklin imposes its taxes county wide. The so-called "bed tax" on visitors is separate from a sales tax, which is paid by everyone on qualifying purchases. The Florida Department of Revenue collects the taxes and returns the funds monthly to the county for funding certain tourist-related functions. Any property owner who fails to charge, collect, and remit the tax to the state is personally responsible for paying the tax and guilty of a crime.

The County Commission makes final decisions about the expenditure of these funds, based on recommendations of the Tourist Development Council (TDC), comprised of local citizens appointed by the Commission. State law requires that the funds be used to promote and advertise tourism. To meet that goal, Franklin County previously spent 60% of the tax to support local projects that enhance the tourism infrastructure. An excellent example is the \$500,000 dedicated this year to the construction of new public restrooms at SGI Lighthouse Park, to be paid for over several years. Approximately 39% of collections is dedicated to advertising and promotion of tourism, including funding of local events. A small portion of the funds goes toward administration.

The additional penny proposed will increase the amount of funds that are available for infrastructure improvements, without an increase in administrative costs. The third penny being considered is well below the state cap on such taxes and the tourist bed tax imposed by neighboring counties. According to state data, tourism is a \$75 Million industry for Franklin County. In addition, our tourists tend to spend at one of the highest levels per capita with each
