SGI Civic Club rules require that every year ending in 5 or 0, the Club should review By-Laws and make recommendations for amendment, if any. The Proposed By-Law changes are found in their entirety on the Civic Club website (see address above). Please vote "yes" or "no" on the proposed changes on the website. Below is a summary for your convenience. These proposed changes and additions to the SGI Civic Club By-Laws are proposed by a committee for this purpose established under Article 11, Section 2, of the By-Laws. Michael O'Connell, Chair. Phyllis Lewis, Member. To make suggestions email mikeoconnell@sgiCivicClub.com.

General Purpose of Proposed Non-substantive changes:

- 1. To reflect the 2019 changes in the legal status of the Civic Club from non-profit corporation to a tax-exempt charitable organization under state and federal law and to incorporate changes in operations required by this designation.
- 2. To codify that electronic notification, voting, discussion, participation, and payments are permissible.

General Purpose of Substantive Changes:

- 1. To provide for Officers to be selected by Board of Directors after election of directors by membership.
- 2. To provide for officers to be limited to two consecutive years in a specific office, such as president, VP, Treasurer, Secretary.
- 3. To provide for a nominations committee to solicit names from membership and recommend board candidates to vote of general membership.
- 4. To provide for a donations committee to solicit recommendations from membership and recommend a charitable donations list to a vote of the general membership.


Section by Section Proposals Section by Section Proposals:

- 1. NEW Article 2: Technical. Defines the new legal status of the organization.
- 2. Article 4: Technical. Deletes incorrect numbering.
- 3. Article 5, Section 1: Substantive. Provides for selection of officers of President, Vice-President, Secretary, and Treasurer by the Board of Directors rather than General Membership. This change provides greater flexibility among directors and officers when needed due to resignation, illness or other extenuating circumstances. The General Membership will continue to elect the seven Directors.
- 4. Article 5, Section 6: Substantive. Limits an officer to serving no more than two consecutive years in a position, or until his successor is chosen. This provision ensures that officers will be replaced regularly.
- 5. Article 5, Section 7: Technical. Removes archaic language in order to conform By-Laws to federal law. A tax exempt charitable entity must purchase all items directly, not through a third party for reimbursement, in order to adhere to its tax-exempt status.
- 6. Article 6, Section 1: Substantive, but tracks current practice and allows electronic participation. Provides for a nominating committee to select a slate of Directors for election by the General Membership and provides for additional nominations and voting by members through electronic means.
- 7. Article 7, Section 1: Technical. Permits the president the option to appoint an independent CPA to review financial records for the preceding year. Provides for presentation to the membership of this report via electronic means.
- 8. Article 7, Section 1: Technical. Removes archaic language to conform By-Laws to federal and state requirements. See proposed Article 5, Section 7 above.
- 9. Article 9: Substantive, but tracks current practice and allows electronic participation. Rewrites this section on Donations to codify current practice of using a charitable donations committee to propose recipients, to establish a timeline for conducting this activity, and to provide for participation and voting by members in person, by mail, and electronically. Creates mechanism for emergency or time-sensitive requests for donations.
- 10. Article 11, Section 1 and Section 2: Technical. Permits the Board of Directors to propose amendments to the By-Laws through electronic means and on paper to members in attendance.
- **11. Article 12: Technical.** Relocates "History" from the body of the By-Laws to an appropriate place on the Club website. Adds appropriate description of these proposals to history.

Groundbreaking for Public Restrooms at Lighthouse Park Scheduled for Oct 20.

This first shovel of sand, marking the beginning of construction, will be turned by District 1 County Commissioner Ricky Jones and representatives of the County Commission, Tourist Development Council, and Storm Construction at 2 pm on October 20 at Lighthouse Park on the island. Also present will be members of the Cape St George Lighthouse Association and the SGI Civic Club.

This infrastructure project is one of the top priorities of the **SGI 2025 Vision**, a long term range proposal for investments in the commercial center of the island, developed by the Civic Club in 2018. In addition to this project, the County Commission has approved a RESTORE grant to address storm water drainage, paving, and parking issues in that area. On August 18, the County Commission voted unanimously to award the construction of the SGI Public Restroom to low-bidder, Storm Construction of Carrabelle. Almost all subcontracting by Storm will be going to familiar local companies. Storm bid \$450,000 for the project, which is being paid for through tourist development fees imposed on short term rental properties. The restroom project represents the largest public works project on the island from the TDC funding source. Site work and construction is expected to begin shortly.





Portable Access Mat Installed October 1, 2020

At the request of the SGI Civic Club, County Commissioner Ricky Jones worked with Fonda Davis, Director of Parks & Recreation to place a roll out, portable access mat at SGI Lighthouse Park to provide access to the beach for wheelchairs, baby strollers, and wagons loaded with toys and gear. The mat has arrived and will be placed on site on October 1, at 10 am.

The mat will be located on the eastern edge of the Park, near the residential skinny minis. That location, already a sandy pathway created by pedestrians, will connect the paved parking and concrete sidewalk, along with the children's play area, to the beach near the water's edge. The ADA compliant access mats are removed when threatened by storms and withstand tough environmental conditions and traffic for years. They are cleaned by a simple leaf blower application. The cost is approximately half of the cost of a wooden board walk and will not need rebuilding, as is often the case for boardwalks after a tropical storm.

The access mats are currently available in the State Park and are enjoyed in many other communities along Panhandle beaches. This is the first portable access mat installed in Franklin County public beaches. Currently, beach accessible wheelchairs, baby strollers, and wagons are available for rent at several island outdoor sports shops. Another nice addition to our island community and Lighthouse Park.

This safe, family-friendly Halloween event will be held in SGI Lighthouse Park. Multiple candy stations will be set up along the sidewalk "trail" with spooky decorations lighting up the park. Local businesses and residents are encouraged to set up a station to pass out candy. Space is very limited and spots must be reserved in advance by emailing info@stgeorgelight.org or by calling 850-653-6880.
